I invite your attention to the references cited above. You are aware that under Article 243 G of Constitution of India, the Panchayat Raj Institutions were mandated for the preparation of their Panchayat Development Plans (PDP) for economic development and social justice. The planning process has to be comprehensive and based on participatory process which involves full convergence with Schemes of all concerned Central Ministries / Line Departments related to 29 subjects listed in the Eleventh Schedule of the Constitution.

In last year's People's Plan Campaign(PPC) Subki Yojana Subka Vikas was rolled out from 02.10.2020 to 31st January, 2021 which enabled District, Block and Gram Panchayats to formulate their Development Plans for the financial year 2021-22. This campaign was implemented quite effectively inter-alia in partnership with the State and Local Governments by capacitating the Panchayati Raj Institutions (PRIs) / Gram Sabha for making the entire process of formulation of development plans in a more participatory and convergent manner.

Further, in the reference 1st cited, the Secretary, MoPR, Gol has stated that, to strengthen sustainable planning, each Gram Panchayat should identify one SDG and take a 'Sankalp' to work towards its attainment during the next Financial Year & plan its activities in the Gram Panchayat Development Plan (GPDP) accordingly. Further, it is felt that, the Gram Panchayats should suitably incorporate the Village Poverty Reduction Plans prepared by the Self Help Groups (SHGs) in the GPDPs for

ensuring inclusive, holistic and truly participatory planning.

I am glad to inform that under your able leadership last year all the Grama panchayats , mandal parsishads and Zilla Praja Parishads have successfully completed the preparation of Panchayat Development plans(GPDP,BDP and ZPDP) . This was much appreciated by the Honourable Minister , Ministry of Panchayat Raj . Further Inspired by this visible and satisfactory performance of the Gram Panchayats, Gram Sabhas and other stakeholders involved in the People's Plan Campaign last year and to provide sustainability to the formulation of development plans into a participative and transparent exercise, it is proposed to launch People's Plan Campaign - 2021 for preparing development Plans at District, Block and Panchayat levels for the Financial Year 2022-23. Like last year, the Campaign would be rolled-out from 02nd October, 2021 to 31st January 2022.

Further, the Department of Panchayat Raj (DoPR), GoI has issued the following timelines for implementation of People's Plan Campaign 2021 in a time bound manner:

The Secretary, MoPR, Gol has further stated that, the experience gained during last year's campaign in the midst of Covid pandemic would provide the necessary stimulus in implementing this campaign this year as well in a more effective and more vigorous way by all the stakeholders. Accordingly, he requested to issue guidance to the concerned authorities (line departments) for roll out of the People's Plan Campaign - 2021 for formulation of development plans for the year 2022-23. It is reiterated that all activities of the campaign should be undertaken in full compliance of COVID-19 Guidelines - maintenance of social distancing; use of face cover/mask to cover face by all participants; maintenance of sanitation and hygiene protocol among others.

In the reference 2nd cited the Secretary, MoPR, Gol has stated that, Hon'ble Union Minister, Panchayati Raj and Rural Development has kindly consented to formally roll out the People's Plan Campaign (PPC) 2021 and launch the PPC booklet on 30th September 2021 at 11:00 a.m. virtually (tentative Minute-to-Minute program enclosed). Hereafter the said booklet will be uploaded in Ministry of Panchayat Raj website.

Nodal Officers Appointment:-

The existing Nodal Officers are continued for this Peoples Plan Campaign 2021 also i.e, Sri Y.V.V.N. Prasad Babu, SPC as State Nodal Officer, The Chief Executive Officers(ZPPs) are continued as District Nodal Officers and Mandal Parishad Development Officers are continued as Nodal Officers at Mandal Level for implementation of PPC 2021 and prepatration & uplodng of GPDPs, BPDPs and DPDPs.

Appointment of facilitator:

The same strategy which is followed in last year shall be followed in the present People's Plan Campaign 2021 also.

Trainings:

The Commissioner, APSIRD is requested to conduct all trainings as directed by the NIRD&PR, Hyderabad in cascade mode and as per the Annual Action Plan 2021-22 by using available funds.

In view of the above, all the District Collectors are requested to issue necessary directions to all the concerned and see that all the activities are carried out as per time lines and procedure prescribed and make the programme a grand success. The Collectors are further requested to ensure that all the line department officials of 29 subjects participate in this campaign in order to prepare a convergent action plan by devolving activities under different schemes.

The Chief Executive Officers, ZPPs and the District Panchayat Officers shall be the Nodal Officers for Panchayat Raj activities. The Project Director, DWMA will be the Nodal Officer from MGNREGA and

relevant RD activities. The Mandal Development Officers shall be the Nodal Officers at Mandal / Block level. They are instructed to tour extensively during the campaign and monitor the total programme by Coordinating with the field staff and also with the line departments. They should see that a proper GPDP is prepared as per the guidelines and necessary reports are from time to time are prepared and submitted/ uploaded properly. All the above instructions shall be pushed to all concerned officers up to village level.

Top-Priority shall be given to this item.
