BROAD OUTLOOK



The local governance system in India comprise of comprehensive administrative and management services for socio economic development of the region in order to improve strategy, compliance, operations and to minimize the risk in the service delivery with a dedicated team of people's representatives.

It functions in accordance with the law of the land defined by the state government and has been successfully implementing development programmes and schemes through partnership between the local governance units and government bodies to enhance effective management of the overall local development.

The units have the responsibility of engagement in policy advisory, participatory planning, community projectisation, peoples budgeting, social audit, internal audits, project implementation, capacity building, mentoring and handholding support, community monitoring and evaluation etc



STATE WISE NE LOCAL GOVERNANCE & ADMINISTRATION:

- Arunachal Pradesh- Two Tier Panchayats -GP, ZP, Gaon Burah, Kebang etc
- Assam -three tier- GP,IP ,ZP & District Territorial Council, Gaon Burah
- Meghalaya -Autonomous District Council, Village Council (Dorbar), Village Employment Council, Headman- Khasi, Jaintia, and Ri Bhoi Hills.
- Mizoram- Autonomous district council, Village Council, Village Employment Council

THE VI SCHEDULE OF THE CONSTITUTION (ARTICLE 244(2) AND 275(1)

- The VI Schedule of the constitution (Article 244(2) and 275(1) has envisaged about the composition, power and functions of District Autonomous Council as extended to four NE States such as Assam, Meghalaya ,Mizoram and Tripura covering following Autonomous District Councils.
- The Autonomous District Councils of Assam: North Cachar Hills Autonomous Councils, Karbi Anglong Autonomous Council, Boroland Territorial Council
- The Autonomous District Councils of Meghalaya :Jaintia Autonomous Councils, Garo Autonomous Councils & Khasi Autonomous Councils
- The Autonomous District Councils of Mizoram : Chakma Autonomous District Council ,Lai Autonomous District Council & Mara Autonomous District Council
- The Autonomous District Council of Tripura: Tripura Tribal Area Autonomous District Council

OBJECTIVES OF VI SCHEDULE



AREAS

- In India, the Schedule Tribes have remained on the fringes of growth, but less so in the majority tribal areas of the North East. This has increased the interest in the VI schedule, the special constitutional provision relating to these areas, recognising the tribal communities, rights of ownership and control over their land and natural resources. These communities have the advantages of protective provisions against "external treats" from the state or private actors, compared to their tribal counterparts in other areas.
- The Sixth Schedule aims to protect and preserve the tribal communities' way of life and was primarily a "settlement" between the Indian State and particular social groups. Individual social justice would presumably flow from protection and preservation of the communities' own social justice Mechanism.

Finance and Data Analysis Cell(FDAC)



- It is proposed to develop a real time, flexible and futuristic data base management system for local bodies in general & PESA areas in particular.
- The data base management cell would be termed as FDAC.
- The strategy would involve establishment of a dedicated Data Analysis cell in NIRDPR/SIRDPR (creation of state based FDAC cell at each of the states and districts involving line departmental officials, Integrated Tribal Development Agency(ITDA) officials, CSC In-Charge, ERs, SHGs/ Federation, agriculture association, youth association, Village committees. Village Heads/Gaon Burah and District autonomous councils etc.

ABOUT ACTIVITY



- Development of MIS reporting formats for annual data collection & compilation on demography,
- Functioning of GPs/Local Bodies, basic amenities, services & resources available with the GPs/ADCs and economic activities at individual and GP level especially livelihood activities.
- The MIS System would also focus on fiscal data management at GP level. The baseline for the activity may be SECC survey data and MA data.

Village Development Index Study Requires:



- Disaggregated data on village development indicators i.e:
- Health, hygiene, sanitation,
- Poverty reduction, social inclusion,
- Women and child development, aged and disabled,
- Education, skill & vocational training, employment & skill development,
- Common property(land bank), infrastructure, natural resources,
- Agriculture & allied activities, production and
- Village level fiscal data including Own source revenue OSR) and other revenues and contributions.

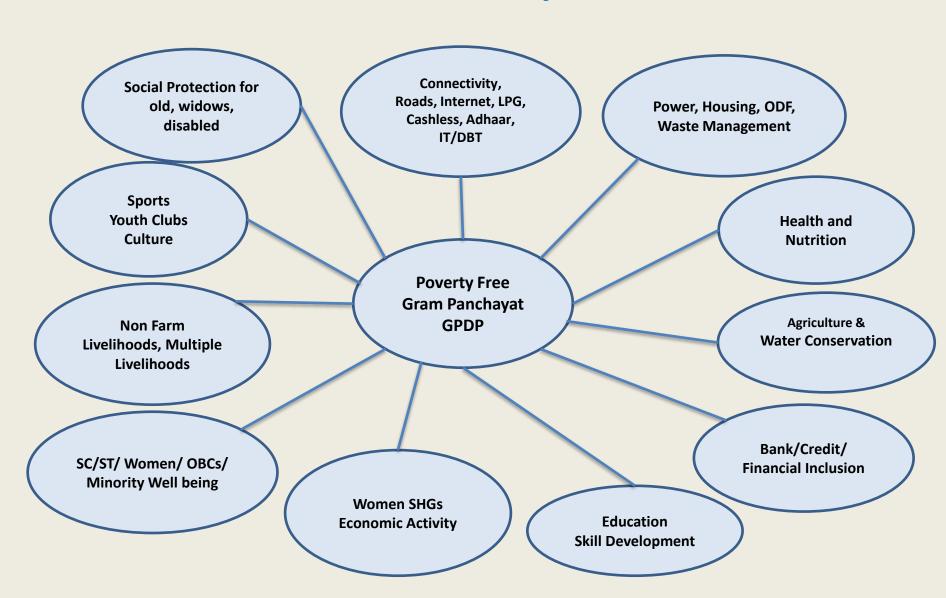
- Development of MIS reporting formats for annual data collection, addition
 & compilation.
- The baseline for the activity may be SECC survey data.
- Data collection, compilation and validation by involving line department officials at local level, VLWs in CSC, ERs, SHG Leaders/Federation, agriculture association, youth association, Village Heads/Gaon Burah etc.
- Measurable Indicators will have vertical and horizontal linkages across line departments to help resource mobilization and feasible action by the GPs/Villages.
- The activity would call for involving ITDA and CSC In- Charge officials to build the architecture of MIS System on data collection and management & hand holding support to various stakeholders like line department officials, state & district level Resource Persons, ERs, SHG Leaders/Federation, Village Heads/Gaon Burah etc.

Expected Outcome:



- It would enable visual tracking & monitoring and data analysis by defining measurable indicators possible for village specific SDGs/localizing of SDGs.
- The system would enable interactive data visualization and Operational & Analytical Data to highlight performance of local bodies and help in planning, prioritizing, strengthening of weakest/ underprivileged areas, in decision making, optimizing of expenditure & resource allocation, asset management and generation of revenues.
