This is in continuation of Chief Secretary's letter No. Secy(RD&PR)-05/2017 dated 11th Sept'2018, for preparation of comprehensive Gram Panchayat Development Plan (GPDP) and its uploading in the Planplus through "People's Plan Campaign" being launched by the Ministry of Panchayati Raj, Government of India w.e.f 2nd October to 31st December' 2018. In this regards, we have to complete the collection of data on Mission Antyodaya frame work in a mission mode and complete the task on or before 28th September' 2018. Such baseline survey reports will be placed before the Gram Sabhas of 2nd October'2018 for vetting and authentication. The authenticated data will be uploaded in the Ministry's portal. In order to accomplish this task successfully and to facilitate the Gram Panchayat Level Interim Committees for preparing a comprehensive GPDP, we need to appoint one person as a Facilitator against each Gram Panchayat who should be at least capable of handling Android Mobile phones. You may please like to appoint the staff of Panchayati Raj Department such as PTAs/CAs/CCAAs, Block Functionaries including Beer Foot Technicians (BFTs) & Gram Rojgar Sahayak (GRS), Community Resource Persons (CRPs) of ArSRLM etc. as Facilitators. These facilitators along with the Chairpersons and Member Secretaries of the GP Level Interim Committees will be imparted training by our DISTRICT LEVEL FACILITATORS under supervision of the Sr. Faculties of the SIRD&PR beginning from 21st September'2018.

Therefore, you are requested to appoint and deploy Gram Panchayat Level Facilitators and Block Level Nodal Officers before 20th September'2018 and communicate the same to the Director (Panchayati Raj), who is the State Nodal Officer by email: arunachalpanchayati@gmail.com enabling him to Plan training schedules. Your cooperation and personal intervention with the assistance of DPDOs and P.D. DRDA is highly solicited. DPDOs and PD, DRDAs are designated as District Nodal Officers for carrying out successful "People's Plan Campaign".
