#### MINUTES OF THE MEETING

# The meeting thoroughly reviewed the People's Plan Campaign performance of all the Districts and found as under:-

- 1. Out of 1785 Gram Panchayats (as per 2013 Election) only 862 Facilators are found to be registered in the GPDP Portal.
- 2. It was found that only 13 Districts have uploaded Gram Sabha photograph in the GPDP Portal.
- 3. One District is yet to register their Block Nodal Officer in the Portal. Matter was instantly discussed with.
- 4. Similarly, there was another such case where Block Nodal Officer was found not registered against 2 Blocks.
- 5. The meeting could not ascertain as to in which Gram Panchayats the Gram Sabhas were held on 02.10.2018.

## After detail discussion, it was decided to hint the Districts to take action as under:

- 1. Immediate appointment of Block Nodal Officers against all Blocks and their registration in GPDP Portal.
- 2. Registration of all Facilators in the GPDP Portal.
- 3. Correct data collection in Mission Antyodaya Framework.
- 4. Immediate finalization of 2<sup>nd</sup> and 3<sup>rd</sup> Gram Sabha Schedule.
- 5. Appointment of Frontline Workers against all Gram Panchayats.
- 6. Uploading of Gram Sabha proceeding photograph (not in standing position).
- 7. Vetting of Mission Antyodaya Data by the Gram Sabha.
