Subject: **People's Plan Campaign - Sabki Yojana Sabka Vikas - Request for disaggregation Budgets and participation of frontline workers in Gram Sabha meetings - October 2 to December 31, 2019**

Enclosed please find a letter that I have addressed to the Secretaries, Government of India of all 29 sectors which are in the XI Schedule of the Constitution of India and where Panchayats are expected to take a lead. The letter is self-explanatory.

2. A Video Conference with all the Additional Chief Secretaries/Principal Secretaries of States and Union Territories was held yesterday i.e. 27th August 2019 and we are encouraging by the tremendous enthusiasm and response from all the States/UTs for the **People's Plan Campaign**. I have 4 specific requests to you: -

- (i) Kindly convene a meeting of all the Secretaries whose subjects fall in the XI Schedule of the Constitution of India at the earliest to enable a robust campaign from **October 2 - December 31, 2019**.
- (ii) Kindly direct the Secretaries of all Departments with subjects in the XI Schedule to undertake a disaggregation of budgets so that a gram panchayat knows what to expect from which department and programme in a given financial year.
- (iii) Kindly also direct every Department to ensure the participation of their frontline workers in the pre-planned Gram Sabha for each Gram Panchayat. It is for this reason that the Gram Sabha meetings have been spaced between October 2 - December 31, 2019 to enable active participation of all frontline workers.
- (iv) To direct the Additional Chief Secretary and the Principal Secretary of Panchayati Raj & Rural Development departments for carrying out the ranking of Gram Panchayats as per formats effectively to enable an assessment of gaps in development panchayat-wise. This will facilitate interventions to remove the gaps early.

Subject: People's Plan Campaign - Sabki Yojana Sabka Vikas - Request for disaggregation of Budgets and participation of frontline workers in Gram Sabha meetings - October 2 to December 31, 2019

As you would recall the Ministry of Panchayati Raj and the Department of Rural Development initiated a People's Plan Campaign called "Sabki Yojana Sabka Vikas" from October 2 - December 31, 2018. Gram Sabha meetings were held in each of the Panchayats across the country during this period and a comprehensive Gram Panchayat Development Plan (GPDP) was also developed. All Gram Panchayats were also ranked on their physical infrastructure, human development, and economic activity during this period. The ranking provided a gap analysis for interventions in each and every Gram Panchayat. All the data is available in the public domain on the website gdpd.nic.in managed jointly by the Ministry of Panchayati Raj and Department of Rural Development. This exercise was very useful in building community connect and in Panchayats taking the lead in integrated need based and community led development.

2. The Secretary, Ministry of Panchayati Raj has already written to all of you about the same exercise being carried out in the current year starting from October 2 - December 31, 2019. The ranking of panchayats has been made even more robust to capture our progress towards poverty-free gram panchayats. The detailed guidelines are all available on gdpd.nic.in. I held the Video Conference with all the Additional Chief Secretaries/Principal Secretaries of Panchayati Raj & Rural Development of States and Union Territories yesterday i.e. 27th August 2019 and there is great enthusiasm in all the States/UTs to develop need based and community led GPDP and to carry out a comprehensive ranking of the Gram Panchayat.

3. For the process to be fully meaningful, there is a need to indicate to the gram panchayat the availability of resources for 2020-21 in each of the 29 subjects of XI Schedule. The subjects covered in the XI Schedule of the Constitution of India are as follows: -

I would urge you to request your State level counterparts to disaggregate the budgets down to the gram panchayat and to ensure the active participation of your frontline worker in the gram sabha meeting. This will greatly improve outcomes in a range of priorities for New India 2022. It is also an opportunity for the frontline worker to share in the gram sabha the work done by your Department and what is proposed for 2020-21.

5. I am separately requesting the Chief Secretaries of States/UTs to take a meeting at their level to achieve the objective of People's Plan Campaign for all the 29 subjects. The disaggregation of the budget Gram Panchayat-wise and the participation of frontline worker will go a very long way in a bottom up community led planning and implementation process to improve the lives of the poorest of the poor. With the deprivation list of households readily available through the Socio Economic Census (SECC), our effort should be to bring all these households out of poverty on a priority. I seek your active cooperation in the transformation of lives and livelihoods of poor households to enable an improvement in their ease of living and their well-being.
