Madam/Sir,

In reference to the letter mentioned above, I am directed to state that Gram Panchayat Development Plan (GPDP) for the financial year 2020-21 will roll out in the districts following participatory planning process, with focus on economic development and social justice by converging all major Government funded programmes.

In view of the fact, it is requested that each and every Gram Panchayat should follow different phases of the process of preparing integrated GPDP for the FY 2020-21 as per the guideline issued from time to time.

Following necessary steps to be taken by all the districts for effective implementation of the process of preparing integrated GPDP through participatory mode.

- 1. Creation of user credentials (User Id and Password) for each Block Nodal Officers and Facilitator cum Charge Officers need to be completed by 5th September, 2019.
- 2. Selection of the Frontline Workers for each Gram Panchayat to be completed by 5th September,2019. It comprises of the officers/officials of the line departments at the Block level and also the officers/officials of the line departments who are operating at the Gram Panchayat level. It is mandatory for the designated Gram Panchayat wise Frontline workers to remain present in the Gram Sabha Meeting for GPDP and discuss the issues related to various sectors of holistic development for integrated GPDP.
- 3. Schedule of Gram Sabha Meeting for placement of draft plan and budget which is going to be held on December,2019 to be uploaded in the GPDP Portal by 5th September,2019.
- 4. Phase wise training programme of the members of the Gram Panchayat Facilitator Team (GPFT) on different components of the participatory planning process to be completed by 31st August, 2019. FCCO and other key Officials of the districts may remain present in

- the programmes as when required and monitor the progress of the capacity building programmes of the GPFT.
- 5. Organising Special Gram Sabha Meeting for initiation of the process of the Gram Panchayat Development Plan for the year 2020-21 to be done from 2nd October to 31st October,2019. All the Gram Panchayat wise FCCOs, Front line workers and members of the GPFTs must remain present in the Gram Sabha Meeting.
- 6. Organising neighbourhood meeting (para baithak) in the hamlets of the villages on different matters of participatory planning. Members of the GPFT will be divided into small groups and organise the meeting with the community people to discuss the essence of the people's plan, objectives of the formulation of the GPDP to ensure the poverty reduction, human development, social development with special emphasis on SC/ST, person with disabilities, women and vulnerable groups, economic development, ecological development, public service delivery and costless development. Different phases of the participatory planning process including data collection through PRA/PLA tools (Mapping Exercises, Focus Group Discussion, Seasonal Diagram, Time Line exercises, Transect Walk etc), situational analysis of the data captured through the participatory process and preparation of the draft plan & budget for the year 2020-21 will be executed in the different phase wise meeting. The entire process of organising phase wise meeting to be completed by 31st October, 2019.
- 7. Draft plan and budget for the financial year 2020-21 to be placed in the Gram Sansad Meetings by 30th November, 2019
- 8. Draft Plan & Budget for the financial year 2020-21 after the suggestion from the Gram Sansad Meeting to be placed in the Gram Sabha by 12th December, 2019.
- 9. Final approval and adoption of the Gram Panchayat Plan and Budget for the financial year 2020-21 in the Special General Meeting of the Gram Panchayat to be made by 17.12.2019.
- 10. Publication of the final GPDP Book and forwarding to the Panchayat Samiti to be made by 20th December, 2019.
- 11. Display of the synopsis of information related to the final plan & budget for the year 2020-21and other related data of GPDP in the Public Information Board to be made by 20th December,2019
- 12. Uploading of the final plan & budget in the PlanPlus software and its approval to be made by 31st December, 2019.

All attempts need to be taken in your district for successful implementation of the initiative for GPDP.
