Madam/Sir,

In inviting a reference to D.O. letters of Additional Secretary, Ministry of Panchayati Raj, Govt. of India as mentioned above (copies enclosed), it is to inform you that the Ministry of Panchayati Raj in collaboration with Other Line Ministries, State Government, Line Departments and other Stakeholders under **People's Plan Campaign –"Sabki Yojana Sabka Vikas" shall be conducted with effect from 2<sup>nd</sup> October 2022 to 31<sup>st</sup> January 2023. Complying with Covid-19 Pandemic norms, the campaign will be conducted on the similar lines as it was conducted in 2018, 2019, 2020 and 2021. The People's Plan Campaign with special reference to Arunachal Pradesh shall primarily be concentrated on preparation of participatory development plan also known as Gram Panchayat Development Plan (GPDP) and Zilla Parishad Development Plan (ZPDP) corresponding to each Gram Panchayat and Zilla Parishad for the financial year 2023-2024 in a campaign mode on the pattern of last four years. The GPDP so prepared will be inclusive of 18 departments related to 29 subjects devolved to PRIs as in the XI schedule.** 

The role out of the preparatory work for GPDP&ZPDP has to be strictly as per the stipulated calendar/timeline and the details of same are as follows:-

- In addition to the above, the Preparation of 'Resource Envelope' corresponding to each Gram Panchayat and Zilla Parishad presentation of the development needs as per the new GPDP & ZPDP format to Gram Sabha/ Meeting shall be core exercises for PPC-2022. You are requested to conduct not less than 2 Gram Sabha to ensure that Gram Sabha deliberate on development issues with integration of Localization of Sustainable Development Goals (LSGDs) as Sankalp taken on 9 themes i.e. (i)Poverty Free and Enhanced Livelihoods Village, (ii) Healthy Village, (iii) Child Friendly Village, (iv) Water sufficient Village, (v) Clean and Green Village, (vi) Self-Sufficient Infrastructure in Village, (vii) Socially Secured Village, (viii) Village with Good Governance and (ix) Engendering Development in the Villages by GPs as adopted by the 1<sup>st</sup> Gram Sabha meeting on 02<sup>nd</sup> October 2022, and information pertaining to all development programmes being undertaken in rural areas is provided properly to the Gram Sabhas and accordingly projects / works of all departments pertaining a Gram Panchayat is incorporated in the GPDP. This process is to be completed by 31<sup>st</sup> January 2023.
- It is also mandatory to ensure that livelihood plan developed by women SHGs under Village Poverty Reduction Plan (VPRP) in all Gram Panchayats presently covered under VPRP are presented to the Gram Sabha for deliberation.
- The annual plan for all rural development and line departmental programmes need to emanate from these Gram Sabhas.
- The Gram Sabhas to discuss on its own source revenue (OSR). Geo-tagged photographs of Gram Sabhas will be required to be uploaded to eGramSwaraj/ GPDP portal.
- The final GPDP & ZPDP as approved by the DPC for the financial year 2023-2024 is to be uploaded on eGramSwaraj portal www.egramswaraj.gov.in by <u>15<sup>th</sup> January</u> <u>2023 positively</u>.

Further, it is important that all the aforesaid directives/advisories shall be implemented in mission mode in your district under your personal supervision.

You are directed to appoint District Nodal Officers, Block Nodal Officers, GP/ ZP Facilitators and Frontline Workers for ZP/ GP whose name and designation shall be uploaded on **www.gpdp.nic.in** of the Ministry of Panchayati Raj and State Department of Panchayati Raj shall coordinate with the concerned Nodal Officers in reference to aforesaid intervention. It is further directed to depute line departmental Village Resource Persons (VRP) to share the departmental schemes and programmes in the Gram Sabha.

You are also directed to issue necessary instructions to District Informatics Officer (NIC) to provide all necessary support for online uploading of data.
