Dear Sir / Madam,

I invite your kind attention to the DO Letter No. K-14016/02/2018-PC, dt. 13.08.2018 of the Secretary, Ministry of Panchayati Raj addressed to the Chief Secretary regarding Participatory Gram Panchayati Development Plan (GPDP) during October 02 — December 31, 2018. I also invite your attention to the D.O. Letter No. Secy (RD)/Misc./2018, dt. 24.08.2018 addressed to the Chief Secretary regarding Ranking of Gram Panchayats on various socio-economic and infrastructure parameters as done in the Mission Antyodaya clusters during the last year. Copies of the letters are enclosed for your reference.

As envisaged in the above communications the State has to collect the information in the prescribed proforma utilising the "Mission Antyodaya App" (MA App) in every Gram Panchayat during the month of September 2018. The data so collected is to be placed for validation in the Gram Sabha of the respective Panchayat in the Special Gram Sabha scheduled to be held from 02nd October onwards.

It is also envisaged to position a facilitator to support the Panchayat and strengthen the SHG / PRI convergence in the Participatory Gram Panchayat Development Plan (GPDP). The facilitators, elected representatives of the panchayats, SHG-CRPs and frontline workers of line departments at Panchayat level are to be capacitated in the participatory planning process during this campaign in addition to equipping the facilitator(s) to collect the data through MA App. Therefore, a National Level Training is scheduled on 6th – 7th September, 2018 at NIRDPR, Hyderabad to cover the above aspects viz. Use of MA App and collection of data, enabling Facilitators, PRI functionaries, Frontline line department officials and SHG functionaries on GPDP preparation and ensuring SHG-PRI convergence. In order to train the above stakeholders in each Panchayat, a cascading mode of training is to be launched on an urgent basis with the help of SIRDPRs/ETCs/District Panchayat Resource Centres / RSETIs through the National Level Resource Persons to be trained on 6-7 September, 2018 at NIRDPR.

The National Level Resource Persons who will be trained at NIRDPR will in turn train the State Level Resource Persons of adequate number who can in turn train all the stakeholders at District / Block level for all the Panchayats.

It is, therefore, request you to attend the training programme and also depute 4-5 National Resource Persons from your State (those who have attended last year training on MA App from SRLM, MGNREGA, additional resource persons and two Faculty of SIRDPR) who can spherehead collection of the data and undertake training programmes.
